



As wind turbines continue to grow higher so too do the safety demands for those working on them.

In most countries it is required by law that the turbine owner makes an annual inspection and test of Service Lifts, ladders, Fall Protection System and other safety equipment in the turbine tower – including inspection of PPE, the technicians personal protection equipment.

Avanti Wind Systems is a professional and authorised wind turbine service as well as safety provider and an international market leader giving Avanti and our well educated staff a clear advantage by way of necessary competencies and experience offering the best service to the wind turbine owners. It is the turbine owner's responsibility that the inspection is done at least one time every 12 months. Avanti offers a service agreement guaranteeing the turbine owner that the safety equipment is inspected every 12 months – or as often as the law or the producer of the equipment require.

The law also requires that the rescue equipment in the nacelles is tested and inspected at least once a year. Avanti Wind Systems is the distributor and service partner for Cresto ResQ.

Therefore, Avanti staff can inspect, test and make a recertification of the rescue, evacuation and descend devices in the nacelle. As a professional and authorised company Avanti Wind Systems also offers inspection for other lifts and ladder systems than Avanti's.

It is also required by law that the owner shall keep a certification journal including dates and detailed descriptions of the testing methods utilized. Avanti guarantees that the documentation for inspection and any possible repairs will be submitted to the turbine owner.

At Avanti Wind Systems we see it the way that annual test and inspection of safety equipment not only is a law requirement – it is also a necessary extra safety precaution for the technicians working in the towers. As wind turbines get higher and higher so does the demands for safety for the technicians working in the turbines.
